<u>DIRECTIONS:</u> From the 15 Freeway (north or south) take the Sixth Street off ramp. Travel east (toward Ingalls Park and the hills) approximately one mile and turn right on California Ave. (there is a light). Go approximately ¼ mile and driveway and sign is on right.

<u>PARKING:</u> All vehicles must be parked in designated parking areas. Access roads are for ingress and egress only. All cars must park in a designated location separate from horse trailers.

ENTRY AGREEMENT: Every entry shall constitute an agreement that the person making it, owner, lessee, trainer, manager, coach, rider and the horse 1) shall be subject to the local rules of the show; 2) that every horse and/or rider is eligible to be entered; 3) that the owner and any of its representatives are bound by the rules of the show and accept as final the decisions of PGF on any question and agree to hold the show, their officials, directors and employees harmless for any action taken.

ADDS/SCRATCHES: Adds and scratches must be completed at the show office using the proper form and can NOT be done at the gate or with the announcer. Scratching must be done one classes prior to the one being scratched for full refund.

NUMBERS: Horses are required to have their correct horse show entry number attached whenever they are exhibiting or warming up.

<u>HELMETS:</u> ASTM-SEI approved helmets with harness and boots are required for anyone on horseback while on the grounds. Proper show attire is required. Black half-chaps are permitted with paddock boots.

<u>MANAGEMENT:</u> PGF reserves to itself the right to interpret all questions and conditions in regard to or arising out of or incident to the Show without claims for damage or recourse of any kind. All questions not covered in the rules and regulations or class specifications shall be decided by PGM whose decision is final.

BILLING: There will be a fee of \$50.00 for all returned checks. An exhibitor may not enter the arena until the class costs have been paid, or has an open check on file.
